The second meeting of the Study Group aims to examine the applicability of Preventive Diplomacy (PD) on on-going security hotspots in the region, notably in the South China Sea, the East China Sea and the Korean Peninsula. What tools have been put forward so far and how effective they have been? All three cases are examples of protracted crises that have evolved over time, following the complex regional political and security dynamics. When the tensions were highest, parties involved tried to put in place some crisis prevention mechanisms to avoid further escalation. What have been the preferred negotiation channels and settings in the various cases? Are there any PD tools identified by the Study that have not been applied yet and could be successful? Ongoing crises highlight the greatest obstacles in the region, urging for open mindedness and creativity in PD.
